Report explores records illuminating the lives and families of each man, one John Pope (1749–1802) who likely was born in Westmoreland County, Virginia, and lived in Prince William County, Virginia, and later in Wilkes County, Georgia, where he died; the other, Colonel John Pope (ca. 1754–1795), who was born in Louisa County, Virginia, lived in Amherst County, Virginia, and died in Augusta, Georgia. Letter, 11 December 1853, from John Gault in Richmond, Virginia, to Samuel Gault[?] in Boston, Massachusetts, detailing John Gault's journey from Boston to Richmond, including stops in New York City; Philadelphia, Pennsylvania, where he visited the mint; Washington, D.C., where he stayed at the National Hotel and saw the Capitol, White House, and the unfinished Washington Monument; and Richmond. Gault comments on the number of African Americans in Richmond and mentions slave auctions. Purchased. (45229)
